## **NOTIFICATION**

It is a matter of pleasure that Ministry of Law and Justice (Legisative Department), Govt. of India publicshed Central Sanskrit Universities Act, 2020 No.t of 2020 in the Gazette of India on 15<sup>th</sup> March, 2020, as enacted by the Parliament and assented to by the President of India. By this Act, Rashtriya Sanskrit Sansthan (Deemed to be University) has interalia been declared the Central Sanskrit University / केन्द्रीय संस्कृत विश्वविद्यालय / केन्द्रीयसंस्कृतविश्वविद्यालय:, with its existing 12 campuses. In pursuance thereof, the Ministry of Human Resource Development (Department of Higher Education), Govt. of India vide notification dated 17<sup>th</sup> April 2020 published in Official Gazette has appointed the 30<sup>th</sup> day of April, 2020 as the date on which the provisions of the Central Sanskrit Universities Act, 2020 shall come into force. As such, Rashtriya Sanskrit Sansthan (Deemed to be University) shall start functioning as the Central Sanskrit University / केन्द्रीय संस्कृत विश्वविद्यालय / केन्द्रीयसंस्कृतविश्वविद्यालय: under the abovesaid Act with effect from 30-04-2020.

Accordingly, it will be required to make fundamental changes in the existing arrangements in RSkS and so, following tasks will have to be operated in the first instance, in each campus:-

- (a) Changes in name/Office Seal/ Emblem of the campuses Schedule-I as Central Sanskrit University Act, 2020 contains 12 campuses of Central Sanskrit University. In that manner, existing campuses will be renamed as under
  - (1) Central Sanskrit University, Shri Ranbir Campus Jammu, Jammu and Kashmir
  - (2) Central Sanskrit University, Lucknow Campus, Lucknow, Uttar Pradesh
  - (3) Central Sanskrit University, Ganganath Jha Campus, Prayag Raj, Uttar Pradesh
  - (4) Central Sanskrit University, Shri Rajiv Gandhi Campus, Sringeri, Karnataka
  - (5) Central Sanskrit University, Jaipur Campus, Jaipur, Rajasthan
  - (6) Central Sanskrit University, Shri Sadashiv Campus, Puri, Odisha
  - (7) Central Sanskrit University, Guruvayoor Campus, Thrissur, Kerala
  - (8) Central Sanskrit University, K. J. Somaiya Campus, Mumbai, Maharastra
  - (9) Central Sanskrit University, Bhopal Campus, Bhopal, Madhya Pradesh
  - (10) Central Sanskrit University, Veda Vyas Campus, Balahar, Himachal Pradesh
  - (11) Central Sanskrit University, Ekalavya Campus, Agartala, Tripura
  - (12) Central Sanskrit University, Shri Raghunath Kirti Campus, Dev Prayag, Uttarakhand

Principal/ Principal I/c of the concerned campuses will have to ensure that the names/signboards of their campus are changed accordingly w.e.f. 30-04-2020.

- (b) Change of letter-heads/concerned stationery items/campus seal etc., Concerned Principal/Principal I/c of the campuses will have to ensure availability changed materials as above for use w.e.f. 30-04-2020.
- (c) Necessary amendments in campus website. Concerned Principal/ Principal I/c will have to get made in the campus website, changes/amendments in nomenclature in campus/activities etc., wherever necessary as per changed setup w.e.f. 30-04-2020.
- (d) Principal/ Principal I/c of the campuses will have to inform all the local authorities, including bankers about the changed establishment and setup and to take necessary action accordingly from 30-04-2020.
- (e) Existing Principal/ Principal I/c of the campuses will be designated as 'Director' of the concerned campus w.e.f. 30-04-2020, till receipt of further formal instructions in this regard. Further that all necessary orders/instructions will be issued by the concerned unit of the University from time-to-time in the wake of Central Sanskrit University status for compliance.
